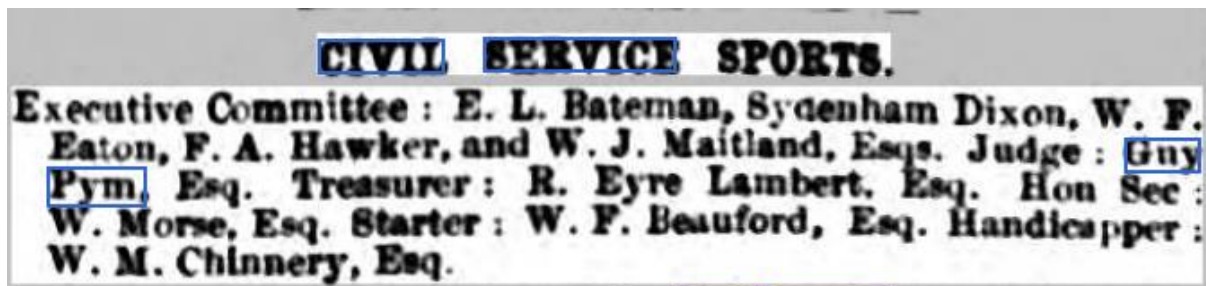

**THE HISTORY OF CSAA 1864 - 2021
CSAA COMMITTEE & CSSC HONOURS**

This section attempts to trace the history of the Civil Service Athletic Association's Committee from 1864 to the present day. From the research it is obvious that in the Nineteenth Century the Committee Structure was very different to what we have today and it is interesting to witness how it has evolved over the timespan. It is also acknowledged that gaps do exist despite the extensive research that has been undertaken.

It also includes the Honours Board which relates to those made by the Civil Service Sports Council over the years for success in sport and service to the Association over many years.

Seven years after the First Sports Day Bells' Life in the London and Sporting Chronicle - Saturday 20 May 1871 printed the names of the Executive Committee (and also the full results and report of Meeting):



Two years later the Executive Committee in 1873 responsible for the Sports Day was:



This reflected the growing interest of these Championships within the Civil Service and London society in general.

Some of the people mentioned above had significant roles within other organisations as well and were not necessarily Civil Servants which again is the case with most of the Track & Field Officials today:

It is interesting to note some correspondence that took place within the Civil Service Sports Journal in the late 1920s as to whether the CSAA should become an official Athletics Club rather than an Association and this is a question that is still asked today. The CSAA Secretary G C Smallwood responded below and it is interesting to note that if an athlete wished to change Clubs there was a 14 month waiting rule:

MR. SMALLWOOD HITS BACK.

To the Editor of the C.S. SPORTS JOURNAL.

SIR,

I have read with considerable interest Mr. Chambers's article on Athletics which appeared in the first issue of the C.S. SPORTS JOURNAL, but while I think his remarks about organisation are sound, I am afraid I cannot agree with some of his suggestions.

In advocating the formation of a C.S. Athletic Club, has Mr. Chambers realised that we should get scarcely any class first claim runners? We cannot expect them to give up 14 months of their best running life to qualify for our Club, and, moreover, the rules of the A.A.A. as to list of members, black book, etc., render the satisfactory formation of a C.S. Athletic Club almost impossible. The question has been considered several times by the Executive Committee of the Athletic Association, but the difficulties appear to be insuperable.

With regard to the suggestion of a match against other teams, we are, of course, well aware that we are practically unbeatable except perhaps by an Olympic team. We have not been idle, but it takes two to make a match, and the Army Sports Board were approached for a match last year, but the effort proved abortive. However, the C.S. Athletic Association is a very optimistic body, and further efforts will be made next year to arrange for suitable matches if there is a demand for them.

Would it not have been better if Mr. Chambers had raised these questions at a general meeting of the Athletic Association rather than have included them in his article? He would then have been placed in possession of all the facts and difficulties of the case of which he is at present obviously unaware.

Another area of disquiet was the number of medals awarded in the Cross Country Championships and again the question of awards and the type has been raised in recent years particularly with regard to the Masters Track and Field Championships.

The letter is replicated below along with a response from one of the leading athletes at the time and a regular contributor to the Journal:

LETTER TO THE EDITOR.

To the Editor of the C.S. SPORTS JOURNAL.

SIR,—Of the 117 starters in the recent C.S. Cross Country Championship 23 received medals. Should not this profusion of gold, silver, and bronze be greatly curtailed? A medal is valuable only as a token of some noteworthy performance, and is therefore an apposite reward for the winner; but it is quite meaningless when given to the man who finishes 86th.

In a team race, the individual prizes should be as few as possible. Give medals if you like to the members of the winning team, to the three placed men, and perhaps the first novice; but could not the other three teams be content with a diploma or certificate of merit?

The number of medals would then be reduced to nine, and their value would be enhanced by the increased difficulty of winning them. Yours faithfully,

THE CROSS-COUNTRY MEDALS.

To the Editor of the C.S. SPORTS JOURNAL.

SIR,—Why does Mr. Ramsay, in your last issue, complain of the profusion of medals showered on unworthy competitors in the C.S. Cross-Country Championship? Does the first novice receive insufficient relative acknowledgment of his merits? Is he afraid the C.S.A.A. will be ruined in these days of economy? Or is it merely a question of principle, the case of casting pearls before swine?

For obvious reasons, the competition in question is essentially a team competition of an inter-departmental character, and no opportunity to encourage the team spirit must be lost. My personal experience, moreover, gives me to believe that a certificate would not be appreciated and in any case, I learn, would not cost appreciably less than a bronze medal.

I rather think Mr. Ramsay's arguments are hopelessly one-sided. For one instance, it is not meaningless, as he expresses himself, to give a medal to a man finishing 80th in the race when one realises that, as a novice, he is not the 80th among those competing for these particular novices' team honours. Besides, if one has nothing in mind except to enhance the value of the awards, why not give only one medal and be done with it?

The Civil Service Sports Journal published details of the CSAA AGM and this is an example from 1927:

* THE ANNUAL GENERAL Meeting of
* the Civil Service Athletic Association was
* held at the Ministry of Health on March
* 31, Mr. Harry Tomlinson, I.S.O., being
* elected to the Chair.

The chief matters for consideration were the election of officers and the programme for the Summer Meeting at Stamford Bridge, on June 11th next, the Diamond Jubilee meeting, being the first of its kind in the world.

The Hon. Secretary reported that in the past year the following events had been held: the flat Events and Jumping Championships, at Stamford Bridge on June, 1926, the 5 miles Cross Country Championship in December, 1926, and the 10 miles Road Walking Championship had been arranged for April 30th next at Regents Park, a Triangular Match between London Athletic Club, Dominion Students Athletic Union and Civil Service had been won by the Civil Service in June, 1926.

The Hon. Treasurer presented the balance sheet which was duly adopted, showing that although income had decreased by about £40 expenditure had been reduced by £38, the net loss on the year being £2 only.

The following officers were elected for 1927-28:—
Hon. Secretary—Mr. G. C. Smallwood, O.B.E.
Hon. Treasurer—Mr. W. R. Frazer, O.B.E.
Hon. Auditors—Messrs. C. A. P. Price and T. J. Rudkin.

For the Executive Committee, to replace the three members retiring triennially, the following were elected: Messrs. A. S. Turk, G. W. R. Robinson and R. Coulthard.

The Hon. Secretary reported that a cup, value £100, was being presented by Lord Queenborough to the Sports Council for presentation to the Athletic Association. It had been decided by the Executive Committee that this Cup should be allocated to a Departmental Competition, applying to both individual and team events, 5, 3, 2 and 1 points being given for 1st, 2nd, 3rd and 4th places, respectively. It was pointed out that we should now have a Victor Ludorum Cup for both the Individual and

the Departmental Athletic Champions of the Service.

The main programme for the June meeting was agreed, and events similar to those held last year will be arranged. It was left to the Executive Committee to introduce such special open or invitation events as may be considered desirable.

An important alteration was made in the qualification required for entrants in the members events. It was decided unanimously that the following should be eligible: "All Civil Servants both permanent and temporary who have been in the Civil Service at least three months before the date of the event in which they wish to compete."

After the General Meeting the Executive Committee met to elect three retired Civil Servants to serve on the Executive for the coming year. Messrs. T. E. Wells, E. H. Pelling and F. Wyborn were

In its 13th May 1930 edition, the Daily Herald proudly announced the formation of a Woman's Athletic Club for Civil Servants which was a significant step forward in those days.

BATTERSEA PARK TRACK FOR TRAINING

The Civil Service Women's Athletic Club has now been definitely formed. The work of the officials will be concentrated on securing the first-claim membership of all newcomers to the Service, while the experience of well-known Service girls, who, however, have become first-claim members of outside organisations, will be the means of setting a high standard for the "freshers."

Miss M. Chidley, of the Customs and Excise, has been appointed hon. secretary, and Miss Dilnot, of the same department, will be hon. treasurer. The Savings Bank Department representative, Miss I. Brereton, will be chairman of the committee.

It is hoped that by the next cross-country season the club's new colours will be a familiar sight in the big events, but apart from steadily coaching the members, the trainer of the Board of Trade A.C., who has kindly consented to lend a helping hand, will not undertake any further activities for the forthcoming track season.

The club will be affiliated to the Civil Service Sports Council, the Civil Service A.A., and the Southern Counties' W.A.A., and for the present the training ground is to be the Battersea Park track.

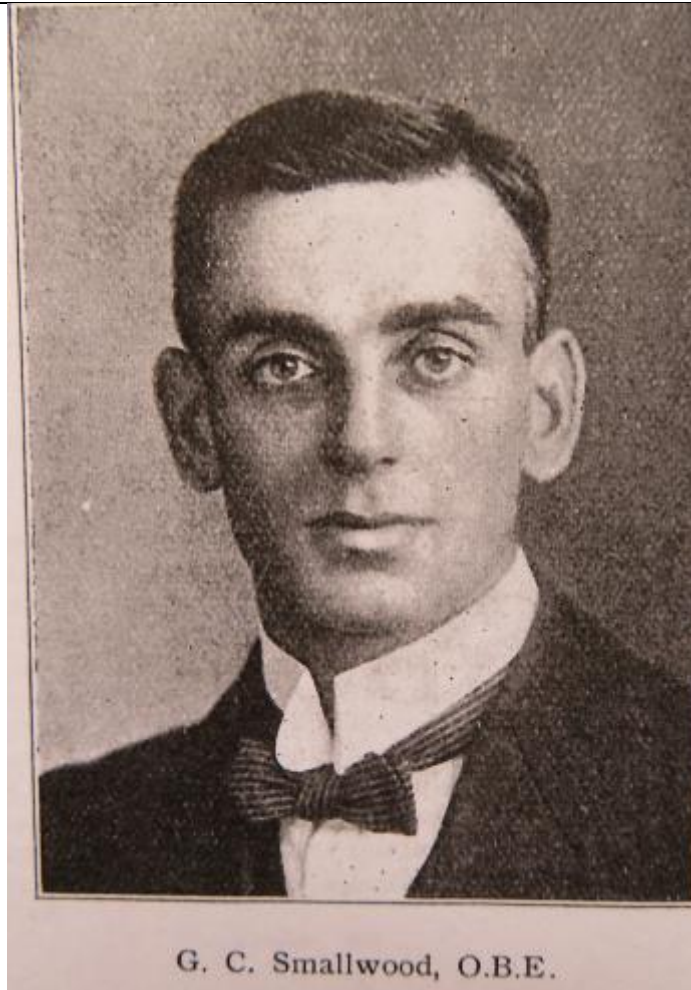

The Civil Service Sports Journal reported in July 1928 the resignation of G W Turk after 30 years on the Committee and a Sports Day Champion for the first time in 1889.

A Resignation. On retirement from the Service, G. W. Turk resigned from the Executive Committee of the Athletic Association, on which body he served for a period of thirty years. As an athlete he was always prominent, and won the 100 yards championship of the Service on three occasions. As a footballer he played for Clapton and Essex, and was one of the founders of the Civil Service Club. He was elected the first captain and held the honour for seven seasons. In his last season, 1902, he took a Service team on a tour through Austria.

Jim Braben Background (from the Windmilers)

Jim Braben was born on 12 August 1906 in Kilburn. At school in the Old Kent Road he was involved with sports from an early age. It was there that he met his future wife Lily. After leaving school, he worked for a short spell at the music publishers, Boosey and Hawkes and joined the Civil Service as a telegraph boy and progressed through the ranks. In 1966 he was awarded the MBE for his dedicated service. In 1983 Jim was awarded the Civil Service Sports Council Certificate of Award of Merit. As a Grade 1 referee and Field Events Judge, he officiated at many national and international events. Although he had always been a runner, swimming was the sport he excelled in, becoming the Civil Service diving champion. Jim and Lily moved to Mitcham in 1934 and he became involved with the Hercules Athletics Club. When he retired in 1965, he took a part time job with the IAAF and was also involved as an official at many National and International track and field competitions, including the 1982 Commonwealth Games in Edmonton, Canada. During the 1960s he was President of Surrey County AAA, Chairman of Hercules AC, Secretary of the Surrey Women's AAA, just to mention a few. In 1933, Hercules Ladies Athletic Club dropped the word 'Ladies' from the title as male athletes were being admitted: Jim was one of the earliest recruits! In 1967 Hercules AC and Wimbledon AC merged to become Hercules Wimbledon AC, where Jim played an important role. Jim also had a major part in the formation of the Rosenheim Track League, which still going strong. In 1976, he used to a lead group of runners from Hercules Wimbledon Park track to the Common, Richmond Park and back. In 1979 Jim, Stuart Nicol (Craig's dad), Jim O'Neill, Pat Gibson (now O'Neill) and Marion Gibson (now Bailey) formed a nucleus that started running from the Windmill which led to the formation of Jim's Joggers, which became the Windmilers. Jim was a Level 4 coach for the British Amateur Athletics Board, now UK Athletics. He was very much interested in Strength and Conditioning and formed Jim's Gym at the Rutlish School in Merton Park. This was later transferred to the Civil Service sports club in Raynes Park in 1983, when it became the Club House for Tuesday evening training.
